### **GENERAL BET REGULATIONS CLEVERPATH HOLDINGS LTD**

#### **Interpretation.**

For the purposes of the present regulations, the following phrases -words shall be interpreted as follows:

“Company” – means CLEVERPATH HOLDINGS LTD under the name Megabet Plus.

“Representative” – a person or a company or a premises authorized by the National Betting Authority to provide betting services on behalf of the Company upon approval by the Company.

“Odds” - It refers to the price that is offered by the “Company” for a specific “Bet”. The “Odds” represent the amount paid by the “Company” for each won “Bet”, of a worth of one betting unit.

“Coupon” -Description of offered “Bets” by the “Company” and which are published in printed and or electronic form for betting purposes and for information of the public.

“Betting ticket”- Each “Ticket” is the unique contract between the “Company” and the “Client”, that demonstrates its existence and ownership by the “Client”. Registered “Bet” printed by the “Company’s” terminal machine, that describes the “Bet” and which the “Customer” receives as a receipt. The “ Betting ticket” contains data about the “Company’s” agency where it that has been registered, the date and time of entry, the unique identification code, the happenings that the “Client” has chosen, the times when they are hold, their “Odds”, the description in kind of “Bet”, lined code (bar code) and other details.

“Bet” - Valid bet that has been confirmed by the “Company’s” terminal machine, registered in the central computer system of the “Company” and for this purpose printed “Bet ticket”.

“Client” - Person that has participated at the “Bets”, organized by the “Company” and for which at least one certified “Ticket” has been issued.

“Regulations” - The present text, which describes the general terms that regulate the holding of the “Bet” between the “Company” and its “Clients”, as well as supplementary terms, which are written on the “Ticket”, on the “Coupons” and announcements that are displayed at the “Betting” agencies of the “Company” or are announced via press or electronic devices, such as teletext or websites.

“ Regulations” are constituting and governing the contractual relationship, as stated herein, and which the parties, as stated herein, hereby agree upon. Regulations are available in several local languages for information purposes and ease of access between players. In any case of a dispute between a Client and the Company or in case of a discrepancy between the Greek version and non-English versions, only the Greek version shall prevail.

“Date of profit calculation” - The time when a “bet” is defined and registered as won, during the procedure that is hold by the central computer system.

## **GENERAL TERMS**

### **1.1 ACCEPTANCE OF THE TERMS OF REGULATION**

With the deposit of any valid betting ticket the client is informed about the present regulations.

### **1.2 ENTRY INTO FORCE OF THE REGULATIONS**

The presents "Regulations" are applied from 24.04.2019 and they regulate all the "Bets" that are accepted by the "Company", regardless of the fact that the "Client" has been informed about them. However, in the case of a disagreement, the "Company" shall try to solve the complaints of the "Clients" directly with the "Clients". The "Company's" "Clients" have to read, accept and follow the following "Regulations". The possession of a "Betting ticket" that has been issued by the "Company" implies what is declared at the same receipt, that the "Client" recognizes and accepts the cited "Regulations" and which he can be advised of at the Betting Agency "Representative" or at any other official site of the "Company".

### **1.3 ACCEPTANCE OF THE BETS**

"Bets" are accepted only from adult clients (over 18 years).

### **1.4 WORKING HOURS**

The normal activities of the Betting Agency ("Representative") can only take place during the determined working hours according to the "Company" (09:00-24:00). The "Company" reserves the right to cancel its preference every "Bet" that is played beyond the working hours of its central offices, even if the "Bet" has been accepted by the computer and the relevant receipt has been printed. The working hours of the "Company" are announced at her official sits. The working hours may be extended during specific organizations.

### **1.5 VALIDITY OF THE ACCEPTANCE OF BETS**

No "Bet" is acceptable and valid until the "Client" has at his hands a valid receipt, "Bet ticket", that is subject to the "Regulations" of the "Company". The "Company" reserves the right to deny the acceptance of all or part of any "Bet", at the moment that it is offered. "Bets" that are played via the terminal of the "Company" are acceptable only if they subject to the general approved procedure of "Betting" of the "Company". No other form is allowed, if it is not exactly approved by the "Company". Only "Bets", which end to the computer archives of the Bet Agency and by extension to the computer archives of the "Company" will be validated and accepted. The "Client" is obligated to check if the printed "Bet" from the computer corresponds to the requested "Bet". If it does not correspond, the "Client" must request the cancellation of this "Bet" within 10 minutes.

### **1.6 CANCELLATION OF BETS**

The "Client" may request the cancellation of the "Bet" within 10 minutes since its printout. In spite of this, if a game that is included in the "Bet", has started before that time period has passed or has choices which "Odds" have been modified, then the "Bet's" cannot be cancelled without the approval of the "Company". Cancellation of bets cannot be realized for bets that concern "LIVEBETTING". Cancellation of "Bets", that do not include invalid games or choices of prices that have been modified, can be requested only in following cases:

- If any mistake exists at the computer of the Bet Agency, the "Representative" and the "Bet" has not been registered.
- If the computer does not print the receipt.
- If a mistake has been made during the entry of the choices of the "Bet" or the amount of the "Bet".

If more than 10 minutes have passed since the “Bet” has been approved, the request for cancellation must be received by the personnel of the “Company”, via email or fax, prior the beginning of the first sport event at the “Bet”. The “Company” has every right to deny the cancellation of any bet. Every representative is obligated to present at the Company all the eventually cancelled coupons that were made at each week. Otherwise, the Company shall charge the relevant amount to the representative’s account and shall deduct it from any future payment or commission.

### **1.7 TIME OF ACCEPTANCE OF BETS**

The “Company” reserves the right to declare as invalid every “Bet”/choice that ends to its network, forwarded from the Bet Agency / (“Representative”), after the beginning of the sport event, to which the “Bet”/ choice refers, with the exceptions of the live “Bets” (“Bets” during the game).

### **1.8 VALIDITY OF BETS**

Every validated “Bet” by the “Company”, shall be written down in the general archive and in a second archive for safety reasons, which is called “safety archive”. The “Odds” (odds) that are current at the moment that the “Bet” is registered, are the “Odds”, according to which the eventual profits shall be calculated. When the profits are calculated, only the content of the receipt from the archives of the central offices from the “Company” are valid. In case in which the clients receipts contain different entries from those who are saved in the archives of the central offices, the “Company” reserves the right to consider only valid the entries, which are included at its safety archives. It should be noted that if the above occurs, the Company has the obligation to adequately justify the correct data.

### **1.9 DETAILS OF BET ACCEPTANCE – ODDS CHANGES**

The minimum number of choices that can be selected in an event (“Bets”), that are permitted per combination and any other restrictive element, are indicated by the computer. It is the Bet Agency’s, person in charge, “Representatives” responsibility to confirm these claims.

The “Company” reserves the right to change any “Odds” according to its judgement. The real “Odd” for any choice remains always the “Odds” that is printed at the moment of the validation on the “Bet Ticket”. For this reason the “Clients” are advised to check their “Bet Tickets” thoroughly.

The “Company” reserves the right, according to its absolute judgement, to cancel all the repeated/same/identical bet tickets, which have been deposited by the same client if (the Company) assumes the act of the client as intentional to deposit 3 and or more bet tickets with the same content in order to avoid the approval of the certain bets.

The Company reserves the right to cancel all repetitive/ similar/ identical betting slips submitted by the same customer if the Company has reasons to believe that the customer intentionally deposited 3 or more coupons/ slips of the same content, to avoid the approval of the specific betting.

### **1.10 APPROVAL OF BETS**

If the Bet Agency, “Representative” receives “Bet” requests that exceed the standard bet limits that are put on by the “company”, it will be necessary, that the person in charge shall request a special authorization for the approval and acceptance of such a “Bet”, according to the “Regulations” and the procedures set by the “Company” from time to time. The betting limits determined by the Company are set at €200.

### **1.11 CONNECTED BETS**

Any relative eventualities (choices with logical connections), such as CHELSEA to win 2-0 and CHELSEA is ahead at the first and second half-time, are acceptable only in odd (after they are

offered for bet by the “Company”, and where wrong cumulative “Bets” are received, the “Bet” will be divided in equal parts for every mentioned eventuality. One exception to this rule, are the “Bets” in which a special combined “Odd” is mentioned.

### **1.12 INDEFINITE BETS**

The “Company” reserves the right to assume single or groups of indefinite “Bets” as invalid, even though they have been accepted by the computer of the Bet Agency, “Representative- Agent”, and even if the “Client” has received the receipt of the “Bet”. The cancelled “Bet” is then returned if the “Client” requests it.

### **1.13 PAYMENT OF PROFITS**

The payment of the profits shall be paid only by presenting the authentic receipt of the “Bet Ticket”, which includes the authenticity code and which authorizes the payment from the computer of the Bet Agency (“Representative”). In case of profit payment with any other way except the aforementioned, the “Company” is not liable. Eventual modifications shall be communicated by the “Company”.

Any winning Bet can be cashed out to two (2) months after the Profit Calculation Date. Any Bet that has not been cashed out during the above mentioned two months, will be considered by the Company expired and worthless except in certain special cases.

The winning “Bet” may be cashed in only at the same terminal machine by which it has been issued. In case of loss, total or partial damage or in general in any case of non-locating and recovering of the winning “Bet”, the claim of profit payment and any other claim for indemnity from the “Company” is excluded. If the result of an event cannot be verified officially the “Company” has the right to delay any payment until the official verification. In case of default profit calculation, the “Company” reserves the right to correct before and after also, the payment of the profits.

### **1.14 MAXIMUM PAYMENT LIMIT**

Each “Bet” is subject to a maximum profit that is determined by the “Company”. The maximum profit for each “Bet” that is offered by the “Company” is written in the special supplement A, which is attached to the “Regulations”. The maximum profit could be minor than the computer calculation (which is written at the receipt of the coupon) and the responsibility belongs to the “Client”, who has to bet accordingly. In these cases, the limits which are mentioned in the “Regulations” are always in force. Limits that may be mentioned at any place of the “Company” (“Coupons”, website) are valid, only if they are not mentioned at the special supplement A which is attached to the “Regulations”. If a “Bet” includes choice(s) that mentions/ mention different kinds of “Bets”, then the minimum maximum limit of payment is valid for all the “Bet”.

## **SPECIAL ANNEX I**

The maximum payment per customer limits are defined as follows:

- Football
  - € 70,000 for all Men's International Matches and the following events: English Premier League, Champions League, League 1, Ligue 2, England Cup, Spanish Premier Division, Serie A Italy, German Bundesliga I, French Ligue 1, UEFA Champions League and UEFA Euroleague, final results (1-X-2) only. Other bet types € 30,000 only.
  
  - € 50,000 for the following events: Australian A-League, Scottish Premiership, English National League, Norwegian Tippeligaen, Portuguese Premier League, Allsvenskan Sweden, English League

Cup, Segunda Spain, Serie B Italy, Bundesliga II Germany, French Ligue 2, Superliga Denmark, Netherlands Eredivisie, Veikkausliiga Finland, Japan J-League, Adeccoligaen Norway, Superettan Sweden, MLS USA, Austria Bundesliga, Belgian First Class A, Danish 1st Division, Scottish Championship, Scottish League 1, Scottish League 2, Swiss Super Cup, Super League Greece and Super League Turkey, final results (1-x-2) only. Other bet types € 20.000 only.

€ 20,000 for all Cyprus 1st Division matches, and Cyprus Cup matches for all types of betting.

€ 20,000 for all other football events and qualifying rounds of all events, including UEFA Champions League, Europa League and FA Cup (Cup), final results (1-X-2) only. Other bet types € 10,000 only.

€ 5000 for all Cyprus 2<sup>nd</sup> and 3<sup>rd</sup> Division matches for all types of betting.

€ 30,000 for all long-term bets (antepost/ outrights).

The maximum payout for All Other Sports is € 15,000 (all types of betting and all the long-term bets (antepost/ outrights)).

Live betting € 10,000 for all sports and all types of betting.

### **Example**

A Bet that includes choices on football, one of which is related to a Cypriot match, is necessarily calculated with the maximum limit for Cypriot matches (if the maximum payout limit for Cypriot matches is lower). For example: Man Utd, Chelsea, Bayern, Omonia (Maximum payout limit of €20000).

All the maximum payout limits mentioned in these rules apply to any Customer or any group of customers who bet together and on the same or similar combination of choice/ choices, even if this is done in a series of Bets, within a price range, during some days. If the Company has reason to believe and considers that a number of Bets have been placed in this way, the final payout of these combined Bets will be limited to a single maximum payout, as mentioned above.

### **1.15 TYPING MISTAKES**

In case of default printout, mistakes on the receipts or obvious errors in the entries, which have been inserted to the computer of the “Company”, the “Company” reserves the right to cancel such “Bets”, or according to her judgement to settle such “Bets” with the right percentages, “Odds”, and even if the mistake is discovered after the completion of the event. The cancelled “Bet” is returned on the “Clients” demand. The “Company” has no liability for the validity of the information that is provide to its “Clients” regarding the dates of holding and the time of the beginning of the games, scores or any other information that eventually shall be considered important by the “Clients”. Mistakes made by the “Client” are not recognized,

The personnel of the “Company” or their branches and the control of all the “Bets” for eventual profits shall be made according to the “Regulations”. Any obvious printing mistake, which is contained in the “Coupon” and in other printed documents, which are published by the “Company” are not binding it. Especially, any obvious printing mistake in matters of price listing, “Odds”, which is paid by the “Company” regardless of any results or combination of results at the “Coupons”, are not binding for the “Company”. Any Return that is at least 30% higher or lower than the average price for the specific bet or bet combination given by Cyprus betting companies (those who hold a legal license to provide Betting services issued by the Cyprus Republic) shall be deemed a clear typing error.

If the “Odds” of the games written in the teletext service or at the live results service of the “Company” are different from the “Odds” that are written on the receipt of the “Bet” that has been

issued by the computer of the Agency, “ Representative”, then those written on the “Bet” receipt, which have been issued by the computer of the Agency, “ Representative” are considered as always right “Odds”, and the “Odds” at the given moment in the teletext service are not binding for the “Company”. Results of events that are written in the teletext service, serve only informational purposes and they are not binding for the “Company”, also.

#### **1.16 REQUESTS AND IRREGULARITIES**

Wherever exists proof of irregularities in a game or any other event, the “Company” reserves the right to cancel or postpone the payment of the choice that is under doubt, until the completion of the investigation realized by the competent official body of any relevant sport. The “Company” shall claim penal sanctions against any “Client” involved in fraud, dishonesty or criminal acts. The “Company” shall deduct payment from any “Client”, if indications or evidence exist for any of the aforementioned. The “Client” shall reimburse and shall be legally liable to pay to the “Company”, on demand, all expenses, charges or damages that shall incur or burden the “Company” (including any direct, indirect or resulting damages, profit loss and loss of reputation) and which result directly or indirectly from the fraud, dishonesty or criminal acts of the “client”.

#### **1.17. COMPLAINTS – BETTING DIFFERENCES – SOLVING DISPUTES**

For any problem, you can submit your complaint with the necessary details and send it to the Company's headquarters within 15 days of the completion of the event to which your complaint relates. For any complaints or requests regarding "Bets", "the Customers" must contact the "Company's" representative where the relevant "Bet" has been registered. Furthermore, under the 20/2017 Directive, pursuant to the provisions of Article 11 (g) of the 2012 Betting Law 106 (I) / 2012, as amended or replaced, the Authority has competences to determine the procedures of the submitting of, and the examining of, complaints to the Authority or an authorized Class A recipient or an authorized representative. In the event that a certain complaint or request cannot be resolved by mutual consent, then it will be referred to arbitration under the Arbitration Law, Chapter 4, of the Republic of Cyprus. The complainant may apply to the three-member committee appointed by the National Betting Authority to examine complaints or infringements. The committee has the authority to hear any witnesses and to get written testimonies from any persons involved, who have to declare any relevant information or data. The procedure has been explained in detail in Directive 20/2017. Once the procedure has been completed, the three-member review committee submits its opinion to the Authority for a decision.

#### **1.18 SUPPLEMENTARY REGULATIONS**

The “Company” reserves the right to modify the “Regulations” by relevant announcement after communication and receiving the related approval from the National Betting Authority. Any previous “Regulation” of the “Company” is considered null, if a new “Regulation” has been issued by the “Company”, which concerns the “Regulation”. The “Company” is not liable if any “representative” has not displayed the “Regulations” or if any “Regulation”, that has been issued and sent to the “Representatives”, has not become aware by the “Clients”.

#### **1.19 INTERRUPTED, POSTPONED AND NOT CARRIED OUT GAMES**

The result at the end of the event will be considered as the final result. All football “Bets” will be calculated according to the normal duration of a game (including the delays). Eventual overtime or procedure of penalty or Golden goal procedure does not count. In case of final interruption before the end of the event, choices that have been assessed (totally or partial) are considered valid. Choices that are considered to have been totally assessed are the choices that are already lost or won according to the result by the time the game has been interrupted and there was no chance of reverting the result if the game would be continued. For example, in football if the supposed game ARSENAL – LIVERPOOL shall be interrupted at the 65' minute and the result is 0-0, then all “Bets” that have not been assessed are null (VOID), but for example, the choice of prediction of the

half time (HALFTIMEBET) that has already been assessed (result X) and any other choice that has been assessed, wins. In this case any who has bet the result of the half time X wins and any who has bet at the result of the half time 1 or 2 loses, because if the game would be continued, the result of their "Bet" would not change. All the people who have bet at the prediction of the right result (CORRECTSCORE) 0-0, have their "Bet" money returned, because if the game would be continued, the result could have changed. If any event/game is interrupted during the game and will be continued within 24 hours from the minute of the interruption, then all the open "Bets" referring to the specific event/game, shall be settled according to the final result. In the contrary, where no event will be continued from the point of interruption but it shall start from the beginning, all "Bets" will be settled as null (void) with "Odds" 1.00 (unit). Predictions for games that are not performed or postponed or interrupted for any reason shall be valid for 24 hours since the programmed starting time. If within 24 hours the game shall not be performed, they will be considered null (VOID) on the "Betting Ticket" and for reasons of profits calculation they are considered (void) with "Odds" 1.00.

### **1.20 GAMES THAT ARE NOT CARRIED OUT AS IT WAS ENTERED AND NEUTRAL GROUND**

The announcement for games that are performed on neutral ground, are realized due to reasons of information and announcement only. The "Company" shall always try to inform/communicate about any change of base or any game performance on neutral ground. The "Company" shall not be liable in case of no announcement/ information about a game that is performed on neutral ground.

### **1.21 CLIENTS LIABILITY**

The "Client" by submitting the "Bet Ticket" declares irrevocably that he has read, understood and accepted fully the "Regulations" of the "Company" as they are displayed in our official sites and recognizes that the acceptance of the "Bet Ticket" is made under the condition of his control and reaching of an agreement with the "Regulations" and the announcements of the "Company".

All "Client's" are obliged to control that their "Bet Tickets" have been completed according to their prognostics and directions. Due to this reason, the responsibility for the correctness of the receipt is subject to the "Client, also.

Mistakes of the "Client", the personnel of the central offices or the "Representative's" of the "Company" are not recognized and the control of all "Bet's" for eventual profits shall be done according to the "Regulations" of the "Company".

### **1.22 TECHNICAL PROBLEMS**

The "Company" is not liable, if any "Bet" could not be validated due to technical problems.

## **SPECIAL CONDITIONS**

### **2.1 RESULTS THAT HAVE BEEN MODIFIED**

Results are those that are recognized in the game field or at the podium of the winners. Any results due to legal, disciplinal or other decisions that modify the results or the finishing line shall not be taken in account. If the investigation of the competent body shall be made the same day of the performing of the event, then the result shall be used and shall be valid, but if it will happen the next day or any other time in the future and overturns the result of the event, **it will not be taken in account.** For example: if Hamilton wins the Monza Grand Prix and the next day is disqualified by the FIA for an offense, all Bets on Hamilton to win the Monza Grand Prix will be valid and settled as winnings.

ANTE POST: In the case of championships where playoffs are held, the final ranking of the leaderboard will only be valid after the end of the playoffs/ league matches in the respective

championship.

## **2.2 THE PLACEBET**

The “Client” selects the “Placebet” if he wants to support a Team/ an Athlete /a Driver to finish in a rank from the predetermined. The profit depends on the specialists conditions of placebet for the specific event.

If bellow the “Odds” of conquest of a tournament the phrase “ $\frac{1}{4}$  ODDSINPLACES 1,2” is written, the “Client” wins the  $\frac{1}{4}$  of the profit that is offered for the conquest if the team on which he bet finishes at the two (2) first positions, or if under of the “Odds” of conquest of a tournament is the phrase “ $\frac{1}{3}$  ODDSINPLACES 1,2” is written, the “Client” wins the  $\frac{1}{3}$  of the profit that is offered for the conquest if the team on which he bet finishes at the two (2) first positions.

## **2.3 DEAD-HEAT REGULATIONS**

In case of an event that is completed in equal amounts with more than one winner, where only one winner was taken into consideration, the DEADHEAT regulation shall be in force. A deadheat result is a result at which two or more contestants share a final position.

In case that two contestants share the final position, the choice is considered won and lost by half, and consequently it is settled with full percentages (“Odds”) and half the price of bet (stake)  
Example:

If 3 athletes share the position of the first scorer at the Mondial Cup, then the amount of the bet is divided accordingly ( $\frac{1}{3}$  of the amount of bet X the odds).

## **2.4 SPECIAL “LIVEBETTING” REGULATIONS**

The “Live Betting” Market shall be offered before and after the duration of an event exclusively from the platform “Live Betting”. The “Odds” shall be refreshed continuously so that they reflect the image of every event. In order to avoid non acceptance of a “bet” due to a change of one or more “Odds” the “Client” may accept the choice “Accept all Odds changes” or “accept higher or lower Odds” during the placing of a “Bet”. It should be noted that the validation of the betting slip is done on the workbench by the authorized representative or the responsible person.

Where this is applied, the statistics that are given to us by the supplier of the service “Live Betting”, shall be used for “Bets” settlement. In case that a covering of an event from the supplier of the service stops or is interrupted due to of a technical problem and causes the wrong projection of “Odds” or the wrong profit calculation, then the supplier shall cancel all “bets” that shall be put during the aforementioned problem. Therefore, the “Company” reserves the right to cancel this kind of “Bets”, due to the obligations according to the contract with the supplier of the service. Where no statistics are given by the supplier of the service there shall be used tapes with evidence, for the support of the way of “Bet» settlement. If for any reason there is no videotaped proof, an independent proof will be used and the Bet will be settled according to the data on the official websites of the respective events/ official sources.

The “Company”, due to its obligations according to the contract with the supplier of service, shall apply following:

If the result of a purchase cannot be defined by official sources, the “Company” reserves the right to delay the payment until the announcement of the official results.

If any purchase is offered and the result of the event is known, the “Company” reserves the right to



cancel the Bets of the specific Market.

In case of obvious mistake at the "Odds", the "Company" reserves the right to cancel the "Bets". "Obvious mistake" is any deviation from the average profit of a coupon in relation with the offered odds by competitor companies which is easy to be detected, according to the rules of common sense and the market practices and it includes in any case cases in which a deviation higher than 100% at the profit of a coupon, as it is written, in relation with the average of the rest of the market.

In case that the broadcast of an event is interrupted due to technical problems and the game shall be finished normally, then all purchases for the specific game shall be settled according to the final result.

In case of default settlement of an event, the "Company" reserves the right to fix it at any time.

In case in which basic regulations of a sport are violated, the "Company" reserves the right to cancel the purchase (for example differentiation of the duration of an event, of the regulations of an event etc.).

If an event has not being completed or did not even started (e.g. due to expulsion, interruption, withdrawal, change in the draw), this will be considered void, except when the bet has been settled.

All the purchases (except the ones in the half time, the overtime and the procedure of penalty) shall be considered according to the normal duration of the event.

The yellow card counts as 1 card and the red or yellow-red as 2. The second yellow card to a player that leads to the red card, does not count. As a result, no player may register more than 3 cards. The settlement shall be done according to all available and existing evidence, for the cards that have been given during the normal duration of the game.

Cards that have been given after the game are not considered.

Cards to non-playing (athletes who have already been changed, training Staff, athletes on the bench who have not been changed), are not considered.

If the market remains open while the various events have already occurred (goal, yellow or yellow-red card, penalty), then the Company reserves the right to cancel these Bets.

If any purchase opens with a wrong red card or by the omission of one, then the "Company" reserves the right to cancel the "Bets".

If the offered "Odds" concern a game with wrong starting time (over 5 minutes) then the "Company" reserves the right to cancel the "Bets". It should be noted that the above cases will be considered a clear error in returns.

If a wrong result is registered, then all purchases shall be cancelled since the moment of the wrong registration. It should be noted that the above cases will be considered a clear error in returns.

If the names of the teams or the classification are registered by default, the "Company" reserves the right to cancel the "Bets". It should be noted that the above cases will be considered a clear error in returns.

The yellow card counts 10 points and the red or yellow-red as 25. The second yellow to a player that leads to a red, is not taken into account. As a result a player cannot register more than 35 points. The settlement shall be done according to all the available and existing evidence, for the cards that have been given during the normal duration of a game.

Cards that have been given after the game are not taken into account.

Cards to non-playing (athletes which have already been changed, training Staff, athletes on the bench which have not been changed), are not considered.

Corners that have been given, but not executed, are not taken in consideration.

Own goals are not considered for the purchase of Anytime Goalscorer and shall be ignored.

Own goals are not considered for the purchase of Next Goalscorer and shall be ignored.

The football players who are playing since the beginning of the game or since the moment of achievement of the previous goal are considered as runners.

All football players who participate in a game are offered for betting. In case in which a football player scores a goal and is not registered in the list, then all “Bets” on football players are normally valid.

The purchase is settled according the broadcast covering and the statistics that are offered by the Mass Media, except if there is evidence that the specific statistics are wrong.

Any complaints related to results shall be stated in writing at the central offices of the “Company” within 7 days since the performance of the event.

Bet Explanation:

Winner of rest of match

Which team shall win at the left time of the game (normal duration) since the moment the “Bet” shall be put. Only goals that are noted after the validation of the “Bet” shall count (the present score shall be printed to the “Bet Ticket”). Own goal shall count for the rival team and not for the team which scored it.

Some events are programed to last less than usual. Under these circumstances the “Bets” shall be settled according the specific particularities. For example some youth football games last 80 instead of 90 minutes, so the “Bets” that concern these certain games will be settle according to the final result of the 80 minutes.

For no reason the cancellation or refund of money for “Bets” LIVE BETTING shall be accepted. If a “Bet” LIVE BET is registered with wrong “Odds” due to delayed broadcasting of the event, the “Bet” shall be considered as NULL with odds 1,00 (a unit), regardless if the “bet” wins or loses.

## **2.5. RESPONSABLE BET**

The “Bet” is entertainment for adults and it is not a way to gain money. Do not provoke your luck. Bet only the amount you can afford to lose. If you believe that you have a gambling addiction problem, call the Mental Health Services at 1454 and the Perseus Counseling Center at 1456 if you are an adult up to 22 years of age. Otherwise, talk to the Company or its intermediaries and consider quitting.

## **2.6 PROCEDURES AGAINST MONEY LAUNDERING**

The “Company” and its mediators are using procedures against money laundering and suspicious transactions shall be communicated to the competent Authorities.

## **2.7 MINIMUM BET AMOUNT**

The minimum bet amount is 1 € per “Bet Ticket”, and 3 cents (0,03 c) per line.

## **2.8 BET ON CYRPIOT TEAMS**

In accordance with article 22 of Regulatory Administrative Act 102/98, a bet on the results of matches with Cyprriot teams either on the territory of Cyprus or abroad is allowed only when combined with the results of matches of at least three foreign teams.
